

### WHAT IS LIHEAP?

The Missouri Low Income Home Energy Assistance Program has two components — EA (Energy Assistance) and ECIP (Energy Crisis Intervention Program). Since both are a part of the LIHEAP program, the eligibility requirements for them are the same, including the requirement that applicants be at or below 135% of the established Federal Poverty Level (FPL) to receive assistance.

The Low Income Home Energy Assistance Program (LIHEAP) helps keep families safe and healthy through initiatives that assist families with energy costs. LIHEAP can help you stay warm in the winter and cool in the summer through programs that reduce the risk of health and safety problems that arise from unsafe heating and cooling practices. During the last several years, CMCA has helped nearly 7,000 families annually restore or maintain their utilities through LIHEAP throughout central Missouri.



This project is funded 90% at \$3,196,122 by federal funds and 10% at \$319,612 by non-governmental sources for a total amount of \$3,515,734.

The federal funds are received from the U.S. Department of Health and Humans Services (HHS) provided by the Missouri Department of Social Services, Family Support Division

# TYPES OF ENERGY ASSISTANCE Output Ou

#### LIHEAP

135% FPL, One time Energy Assistance (EA) benefit based on winter primary heating source, income and number in the family. Shut off notice required for emergency ECIP funding. Up to \$800 for winter heating crisis; up to \$600 for summer cooling crisis.

#### CLEAN SLATE

175% FPL eligibility.
One time payment may clear out any outstanding Ameren Electric arrears over \$600.
Customers responsible for 25% of the bill (may use LIHEAP Crisis funds if eligible).

#### DOLLAR HELP

200% FPL eligibility,
Assistance in Cooper,
Howard and Moniteau
counties. May be used for
electric, gas or propane must be the primary heating
source.

#### DOLLAR MORE

200% FPL eligibility. Must be an active Ameren customer. Maximum benefit of \$600 per calendar year. May be used for any utility provider for heating or cooling.

#### KEEPING CURRENT

150 % FPL Eligibility 2-year Ameren program. Families must pay monthly payment and if payments are made on time, the family will receive a monthly credit for their Ameren account based on family income.

#### KEEPING COOL

50% FPL eligibility. 3 month Ameren program (June, July, August). Families may receive \$25 credit on their monthly bill. Auto enroll for the second year after enrollment the first year. Focuses on seniors and individuals with disabilities.

#### CALLAWAY COVID

200% FPL eligibility for Callaway county residents to be paid to any Callaway county based utility provider including heating, cooling, water, sewer, trash and internet. Arrears must be for services from March - June 2020.
