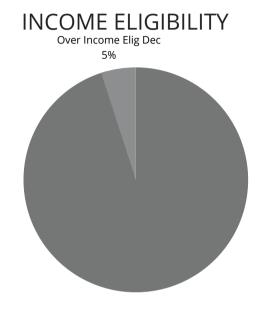


EARLY HEAD START REQUIRED REPORTS

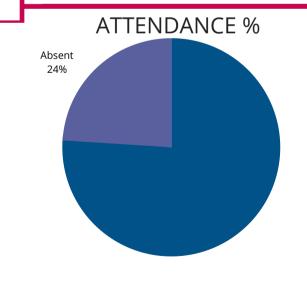


NEW AREA: EARLY/HEAD START REQUIRED REPORTS

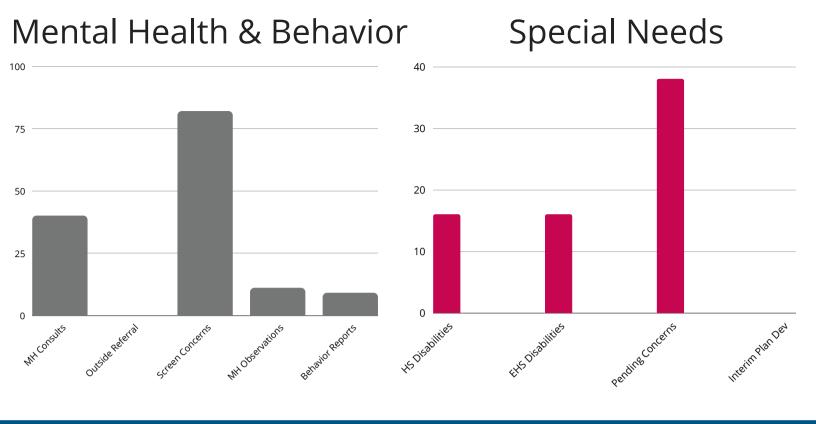

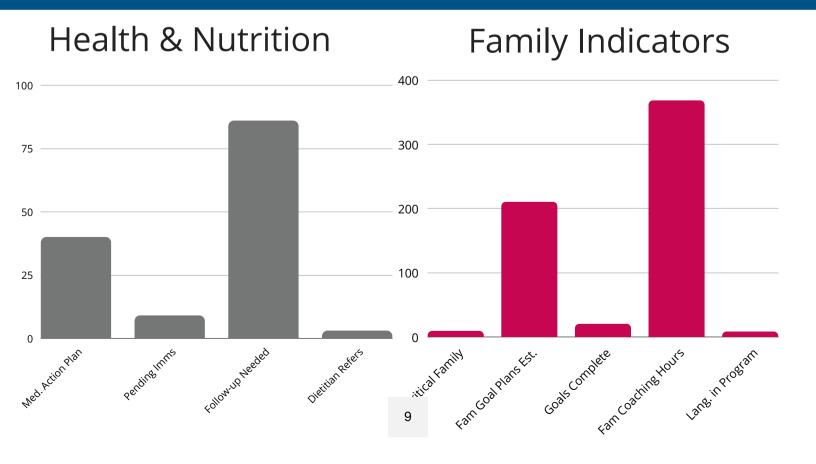

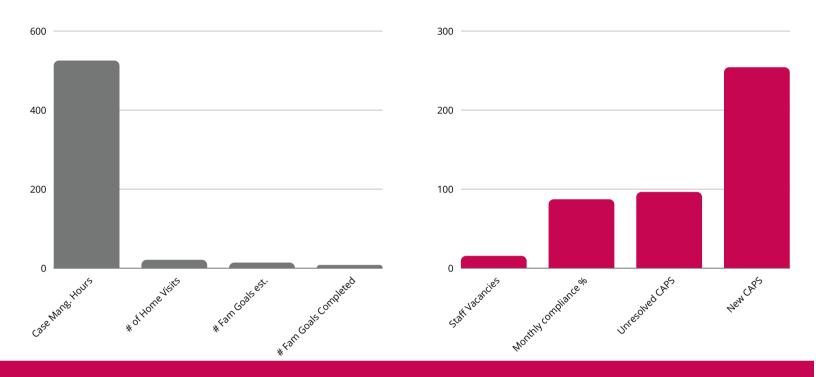

- Positive feedback to CO presentation; "Wanted more of it!".

*Maternal Mental Health Coalition

- Callaway County Health Dept began administering the Edinburg Screening to ALL WIC families in Callaway County.
- 30% of families that were screened prompted a mental health referral.
- In July, SB788 was passed in MO. (Senator Schupp)
 - Mothers with Medicaid coverage with a positive PMAD screening before 60 days postpartum can extend Medicaid coverage for MH TX for an additional 12months!
