

Kauffman Foundation Leadership Lab

Executive Director Darin Preis and Missouri Women's Business Center Director Jayme Prenger were invited to join the inaugural Kauffman Foundation Leadership Lab for Entrepreneur Supporting Organizations (ESOs).

This year-long cohort is charged with facilitating the co-creation and innovation of entrepreneurship support to small business owners in Missouri and Kansas. We are proud to be one of ten prestigious entrepreneurial organizations in the state selected to participate in this opportunity.

Financial Education

Financial Opportunity Center Coaches hosted a virtual class titled "Stretching Your Food Dollars." The class was promoted by our partners, resulting in 63 registrations and 26 attended. We are exploring options that will allow us to host a second class. The FOC and WBC partnered to present a Credit Awareness Class for small business owners. This class walked through personal credit and business credit as well as myths and obstacles to avoid. Additional financial workshops are planned for various partners throughout the community, including

the Boonslick Heartland YMCA, Burrell Behavioral Health, Stonebridge House, and Central Missouri Foster Care & Adoption.

Be on the lookout for our new podcast, "Financially Fit with FOC." The new podcast will provide easy-to-digest financial education for the public. The first edition of the Employment & Training Newsletter will come out in September, and will feature information on the SkillUP and FOC programs, as well as financial tips and tricks and information about upcoming CMCA events.



The Shops at Sharp End



CMCA was awarded \$397,821 to support the establishment of a brick-and-mortar retail incubator with our Women's Business Center. Boone County awarded funds to support this initiative through September 2026. Our partners include REDI (providing the space and retail displays) and the Downtown Community Improvement District (The District) that will be providing marketing and promotions.

The retail incubator will be located in The Shops at Sharp End, a historically black business district in downtown Columbia that was later destroyed by the urban renewal movement. It will open late 2024 and will provide a physical store front for black, minority, and female entrepreneurs to offer their products, test the market, and receive formal retail training.



Capital Hill Day

In July Women's Business Centers from across the country gathered for the national conference hosted in Washington D.C. The annual conference provides updates from the SBA and allows WBC's an opportunity to share best practices. This year was exceptionally exciting for the attendees, as they were able to sit in on a special Senate Hearing on Women's Entrepreneurship. The four women business owners who testified during the hearing shared their experiences at their WBC, the support they received and how the center was pivotal in their success. We are fortunate to have four WBC's that serve clients in Missouri and we look forward to joining forces in the future to represent all Women Entrepreneurs in Missouri!






Total Energy Assistance Applications Processed (EA)







Cole County

The day center for homeless people in Jefferson City has been named. Open Doors is still working on a permanent location and is exploring several prospects.

One unhoused member was finally able to find market rate housing and get off the streets. Volunteers helped furnish her apartment, and we are so excited for her.

Seven students in the Short Term Occupational Training program completed classroom training in July. These students received 100% tuition assistance via SkillUP, WIOA, and FOC programs. Once the students complete their clinical hours, they can test for the CDA exam.





Strengthening Communities



Cooper & Howard Counties

CMCA received \$6,000 in funding from the City of Boonville CIP Tax Funding to launch a vehicle maintenance program for city residents using city auto repair and parts shops. Qualifying members are working households at 200% FPL and funding up to \$400 is available for specific maintenance & repair services. We will host a car care clinic in the fall in partnership with the Impact Activity Center, and the Vehicle Maintenance Program will launch in August.

CMCA distributed 24 window air conditioning units to families as part of the Ameren Missouri CommunitySavers grant program.

The Boonslick Education & Employment Expo will be held October 12th at the Isle of Capri Casino. The steering committee developed a new media plan for the expo using traditional advertisement as well as targeted Google ads.



Moniteau & Osage Counties

CMCA participated in a Back to School drive thru fair which served 480 school-aged children in Moniteau County.

Moniteau County Healthy Lifestyles has 5 students that attended camp in Jefferson City to learn a skit to present to their schools about being drug free. They will perform in October during Red Ribbon Week in Moniteau County Schools.

A Taste of Osage will be held September 10th. Over 40 vendors have registered on the event, which will focus on Osage County small businesses.

Early Childhood Program Updates

We FINALLY got approval for our building project in Warsaw! We are now working out details for purchase and construction and beginning the process of hiring and training new staff.

CMCA was selected to participate in a mandatory Improper Payment Study through the Office of Management & Budgets. We were able to provide all the necessary information and documentation.

We have been able to fill the newly created position of Applications Processor. This position will be a significant step in our program's Eligibility, Recruitment, Selection, Enrollment & Attendance (ERSEA) process.

The Head Start administrative team has been busy this summer preparing staff trainings and updating policies and procedures for the new year. All sites were closed in early August for staff pre-service training on all the program updates.

Administrators also worked to complete our annual Program Information Report (PIR). This report goes to Congress and shows the work that we do at the program level. The accounting team finished closing out the fiscal year for the 8-county service area, and all required reports were submitted. We will not turn our attention to closing out the 3-county area fiscal year.

BRIDGE hosted annual professional development training for contracted public school teachers. Teachers were able to learn about poverty, social-emotional learning, understanding emotions, health and nutrition, and self-care/self-compassion. BRIDGE also welcomed three new Family Success Coaches to the team. We are so very pleased to introduce Madeline Wilson, Janylah Thomas, and Aaliyah Williams!






Head Start Enrollment & Attendance June & July




Children Affected by Site Closures




Actual Enrollment

Income Eligible Enrollment




Disabilities Enrollment



Head Start Enrollment & Attendance by Site June 2023


Actual Enrollment by Site

as a Percentage of Actual Enrollment





Head Start Enrollment & Attendance by Site July 2023


Actual Enrollment by Site





Show Me Strong Communities

CMCA hosted the second round of community planning meetings through the Show Me Strong Communities initiative. The SMSC initiative is designed to guide community members and partner organizations through the process of developing Community Action Plans that address community needs identified through a series of data walks and community surveys earlier in the year.

SMSC Program Manager Kelley Lucero facilitated the latest round of meetings that focused on identifying partners and existing efforts within each county. CMCA also distributed partner surveys which garnered 153 results, not including Boone County. Responses from the community planning meetings and partner surveys will be combined to update CMCA's existing Resource Directory. Responses will also be used to create a publicly-available, interactive GIS Resource Map that will allow for better analysis of each county's distribution of resources and will help CMCA and its partners facilitate inter-agency referrals for members.

Senior Programs

Foster Grandparents Program held a Senior Expo in Callaway County, as well as recruitment events in Mexico, Moberly & Boonville.

The RSVP program connected with the Cooper County Health Department and Jackson Road Medical Building to assist in finding clients who may need assistance through our Transportation and Companionship programs. Several possibilities are evolving. RSVP is also sponsoring a clothing/food drive this fall and is seeking donations of warm clothing.

Poverty Simulations

CMCA partnered with the Columbia Public Schools Health Services Team to host a poverty simulation for their inservice day. Funded by a grant from the Missouri Department of Health & Senior Services, 55 school health professionals were able to simulate four 15 minute "weeks" as a person living in poverty. The group gained insight on what a month may look like for families living with a low income and how that may affect the families they work with on a daily basis. CMCA plans to conduct additional poverty simulations for public & school-based health professionals with additional funding through the grant.

SHMR Expands Access to Classes

ShowMe Healthy Relationships is a University of Missouri program offered through various grantees state-wide. When another community action agency was no longer able to continue the SMHR program, CMCA was able to step up and help fill that gap. CMCA will take on additional staff and members from OACAC to help ensure that individuals are able to continue to benefit from the classes. This will double the number of participants that our program is able to serve.

SMHR has also been working to expand access to justice-involved individuals. Staff recently provided a presentation to 58 offenders in the pre-release program at the Women's Eastern Reception, Diagnostic & Correctional Center in Vandalia.



Project Homeless Connect

CMCA participated in the Boone County Project Homeless Connect, which served over 175 unsheltered people. The SMHR team provided 150 goodie bags filled with essential items at their resource booth.

Attendees connected with groups from across the county and received medical services, haircuts, and applications/referrals for additional services.


ShowMe Healthy Relationships Success Story
