# 2024 Commissioner of the Year



The Shops at Sharp End celebrated a major milestone with our one-year anniversary celebration. The event was designed to highlight the efforts of our participants and reinforced the program's commitment to fostering retail entrepreneurship.

The Shops at Sharp End hosted the 6th Annual Black Expo, which provided a valuable opportunity to network with sixty other vendors and showcase the brands of our participants to the wider community. Continuing the Black History Month celebrations, we partnered with the Black Professional Society to host the Networking Mixer, featuring three esteemed keynote speakers – Barbra Horrell, Fran Tibbs, and Mary Ratcliff – who shared the history of the original Sharp End and the thriving Black businesses that existed there in the 1960s. 



Federal actions resulting in confusion about Weatherization BIL funding and paused our work. There were no additional homes weatherized during the month of February.











#### **Audrain County**

CMCA participated in a new housing taskforce that intends to address housing needs in Audrain County. The taskforce is currently working on developing an up-to-date landlord list.

We also participated in ACCORD's awareness event and handed out Narcan and educational information about drug prevention.



#### **Boone County**

Congratulations to Onni Flint, our new Boone County Community Organizer! Onni has jumped into her new role by attending Upward Mobility housing planning meetings, contracting for two spring poverty simulations, and preparing tables & booths for several upcoming community events.

Our new infant/toddler building at Worley Head Start is now open! We have one more classroom to move in at the end of May, but are excited to have the new space open for children and families.



#### **Callaway County**

Community Organizer Kellie Pontius organized an apprenticeship opportunity for a COPIC WIOA Youth Work Experience participant. Head Start will provide the onsite training and COPIC will provide the paid training up to 320 hours for the high school student. After the training hours are complete, the participant will complete on-the-job training, and COPIC will reimburse Head Start 50% of their wages. After completion, the WIOA youth will receive a credential and possibly a career pathway into the education field.

The 2025 Boonslick Education & Employment

Expo will be held on April 2<sup>nd</sup> at the Isle of Capri Casino Hotel. This year we are partnering with the Boonville-Area Chamber of Commerce, Boonville Technical Education Center, and the Heart of Missouri Regional Professional Development Center. Last year, the EXPO committee moved this event to the spring to allow us to focus on career readiness and employment opportunities for students looking for employment directly after high school. Students enrolled in area college programs and job seekers in the community are also encouraged to attend.

Community Organizer Cheri Cherry attended Cooper County's Sequential Intercept Model (SIM) two-day workshop organized by Cooper County Administrator and CMCA board member Paula Sims. Board member/community advocate Khyeese Bethea also attended. Other participants included members from county and city government, emergency management, the health department, local law enforcement, mental health care providers, State Representative Tim Taylor, and other community stakeholders. The goal is to provide assistance and resources to those with mental health issues that would otherwise fall to law enforcement agencies.

### **Early Childhood Program Updates**

Winter weather caused many of our centers to close, with some road conditions affecting children's ability to attend when the centers re-opened. The weather contributed to the program falling below the expected 85% average daily attendance for the third month in a row. As required by the Head Start Performance Standards, we reviewed children's absence reasons and did not find any concerns. The top three reasons for child absence in February were: child illness (28.5%), family illness/death (19.5%), and inclement weather but center was open (18.2%). These are reasonable absences for the winter season, so we have no

We were able to re-open one infant/toddler classroom in Boone County to half capacity in February. We expect to open Callaway EHS, which is currently at half capacity, to full capacity in March.

concerns at this time.


### Head Start Enrollment & Attendance February 2025




### Children Affected by Site Closures




#### **Actual Enrollment**

#### **Disabilities Enrollment**




### Head Start Enrollment & Attendance by Site February 2025

#### **End of Month Enrollment by Site**


as a Percentage of Funded Enrollment










### Infants & Toddlers Developing At or Above Age Expectations

(Middle of Year, Children with Two Data Points)



Data indicates that the majority of infants and toddlers continue to meet or exceed developmental expectations. A slight decrease in children meeting age expectations for cognitive skills appeared for children enrolled in two particular classrooms and one home based caseload. Additional analysis indicated that the decline in cognitive skills was reported for a total of three children. These children will receive individualized supports through their child goals.


Preschool outcomes reflect the average scores on the HighScope COR for each developmental domain. This tool measures achievement of curriculum indicators, as indicated by a score of 4 of higher.

Children from one classroom had lower average scores and also reported a decrease in scores since the beginning of the year. This classroom has a very experienced teacher and extensive mental health, behavior, and education supports already in place.

Pre Mid ····· School Readiness Target






### **School Readiness**

School readiness is assessed for all children who will be age-eligible to enter kindergarten in the fall. The graph indicates the percentage of kindergarten-eligible children who are meeting each school readiness goal.

Kindergarten-eligible children made significant growth in all areas of development, but particularly in language & literacy and cognitive skills. There were no notable differences amongst demographic groups or classrooms.


