We are so grateful to United Way of Central Missouri for selecting us as a recipient of a Community Support Grant! Their donation of \$6,468 will benefit our Head Start program.






Agency Employment & Financial Coaching Outcomes

Financial Education










Outstanding Housing Vouchers

Strengthening Communities



Audrain County

CMCA partnered with the Audrain County Shelter Resource Coalition to offer coaching services to transitional housing residents. The Family Success Coach will support residents in budgeting, finding a job, and housing through weekly coaching. FOC staff will provide additional financial planning education on a monthly basis.



Boone County

Multiple CMCA programs were represented at Boone County's Project Homeless Connect event, which had a huge turnout. We also hosted tables at various community events, including Family Fun Fest, the Daniel Boone Regional Library, and the Welcome Home Application Blitz,

Callaway County

The Early Education Coalition has placed six high school students into early education worksites under the apprenticeship program, and two additional students will begin in August. Five of the eight students receive WIOA services.

The Short-term Health Occupation Team is offering Certified Nursing Assistant training this fall. SHOT is led by CMCA in partnership with Job Point, COPIC, Kingdom Care, and the health department.

CMCA facilitated poverty simulations for the Missouri Behavioral Health Council's Missouri Connection Conference for various social service agencies across Missouri. St. Louis Probation and Blue Springs Police Department requested simulations for their area after participating and have been referred to community action agencies in their counties.

The Harlem Wizards are returning October 15th to raise money to support housing efforts in Callaway County. We are actively recruiting for sponsorships and engagement for another successful event!



Strengthening Communities



Cole County

The City of Jefferson City Council voted to waive the existing \$14,000 liens on a lot at 410 E. Hess Way. CMCA is pursuing purchasing this lot to build an affordable home.

JCRATI (Housing the Community – Jefferson City) hosted a well-attended press conference to advocate for a permanent location for our cold weather shelter. The event received strong media coverage, including a feature in the News Tribune. We're hopeful that this visibility will generate promising leads.

Representatives from City Council, local organizations, Empower Missouri, and other stakeholders engaged in productive discussions regarding community land banks. It was ultimately determined that the current number of properties is insufficient to support the establishment of a formalized land bank through the city at this time.



Cooper & Howard Counties

Ameren Missouri donated 28 Energy-Star certified window AC units to Ameren residential customers in Cooper and Howard Counties.

We received a large donation of adult socks and 875 personal hygiene kits from the Isle of Capri which have been popular with our members. The Boonslick Basic Needs Community Action Team received an additional 100 pairs child-sized socks from Milestones Day Care for the Back-to-School Clothing Drive.







Strengthening Communities



Moniteau & Osage Counties

Moniteau County held a Back to School Fair. CMCA helped distribute 450 bags of school supplies and 120 body care bags.

We partnered with United Way and the Moniteau County Health Center to provide a Safe Sitter Course for eight teenagers to learn essential skills for staying home alone and caring for young children.

In Osage County, Shop with a Hero held a pork burger sale to raise funds that will allow 40 children to shop with local law enforcement in December.

CMCA helped launch a survey to measure interest in a senior center that would provide a place for seniors to socialize, gain resources, and a meal. The survey will help determine if there is enough interest to sustain the program.

The 5th Annual Taste of Osage will be held September 13th, featuring nearly fifty local vendors. Please join us and support Osage small businesses!







Early Childhood Updates

The Benton County Early Learning Center is finally ready to open! All of the red tape has been managed, and we're finally open to Head Start children and families! The center just received new playground equipment, and the kids are eager to try it out. We invite you to join us for a ribbon cutting ceremony on August 25th at noon in Warsaw.

The FY26 Senate Appropriations Committee adopted and sent to the Senate floor a bill that increases Head Start funding for Fiscal Year 2026 (FY26) by \$85 million! That is good news for Head Start, and we will keep you updated as more information comes out. We are still waiting for guidance from the Office of Head Start on how to proceed with eligibility requirements.







Head Start Enrollment & Attendance June 2025




Children Affected by Site Closures







Income Eligible Enrollment

Disabilities Enrollment






Head Start Enrollment & Attendance by Site

June 2025


End of Month Enrollment by Site

as a Percentage of Actual Enrollment







Head Start Enrollment & Attendance July 2025




Children Affected by Site Closures




Actual Enrollment July Target




Average Daily Attendance

Head Start Enrollment & Attendance by Site


End of Month Enrollment by Site








Keeping Informed

Multiple CMCA staff attended a recent statewide Missouri Rural Food Access Partnership meeting to learn about the potential impacts of new federal legislation on various sectors of the food system. Staff participated in discussions focusing on food access in communities and schools and how that ties into the social determinants of health.

Community Organizer Cheri Cherry serves on the Cooper County Health Improvement Planning Committee's Health Education, Nutrition and Obesity

sub-committees. During the initial meeting, the group developed a result statement, or goal, for their work and began developing a survey to collect data from WIC recipients about their needs.

Healthcare Advocates attended the June Cover Missouri conference and gained updates on local, state, and federal levels on Medicaid and the Missouri Marketplace, including changes for children of immigrants and changes in tax credit eligibility.
